If you are a USFSA member with a club other than AFSC, you **must** provide a Letter of Permission from your home club as stated in TR 3.08 of the USFSA Rulebook stating that you are in good standing and are eligible to test with your test application. Individual members of USFSA **must** provide a copy of their current USFSA membership prior to testing. Written certification of membership is also required of candidates who are members of member associations of the I.S.U. as stated in TR 3.07 of the USFSA Rulebook.
